Description: Expanded, closed-cell or semi-open cell foams and solid films of Acrylic (adhesives and GHB), Modified Polyester (TPC-ES examples: CP, ESL, PS), Polyethylene (PE Series examples: E, EG, EI, EM), Polyvinyl Chloride (PVC Series examples: A, BR, C, EP, F, L, LC, LD, MC, MW, SO, ULD, V, XP ) and Polyvinyl Chloride/Nitrile-Butadiene Rubber (PVN) in various combinations of roll , sheet and tape forms.
